Stallion bonuses will not be paid unless the stallion is properly registered with the WVTBA as a West Virginia stallion. Original registrations or renewals must be made before covering his first mare of his first West Virginia season. **(Original registration one time only. Renewals annually)** Stallion must be PERMANENTLY DOMICILED in the State of West Virginia to receive stallion bonus awards from the Development Fund. Annual renewals must be filed by February 1<sup>st</sup> each year to remain eligible.

**Stallions sold or moved from the State at the end of the breeding season must make renewals annually** to collect Stallion bonuses for progeny running in West Virginia that he sired before moving from the State of West Virginia. If moved during the breeding season, no bonuses will be paid for foals conceived that year. Upon moving a stallion out of state, the owner must report in writing, prior to February 1<sup>st</sup> of the next year, the date the stallion physically left West Virginia and the destination.

Any change of ownership or stallion location must be reported to the WVTBA in writing.

**Deceased or gelded stallions:** Date of death or veterinary report of castration must be reported to the WVTBA in writing prior to February 1<sup>st</sup> of each year following the death. No renewal payments are necessary. Bonuses will be paid automatically after the report has been received. However, for the 10-10-10 program, this does not apply. Forms for the 10-10-10 must be filed separately with the West Virginia Racing Commission.
