Definition of "RAISER": Owner of the yearling at the time it finished twelve (12) consecutive months of verifiable residence in West Virginia. During the period, the RAISER will be granted one (1) month of grace for his or her horse to be shipped to and from thoroughbred sales where the horse is officially entered in the sale catalog of a recognized thoroughbred sales company. Prior to the horse being shipped out of West Virginia for sale, the Raiser must notify the west Virginia Racing Commission of his or her intention. **NOTE: COPY OF BILL OF SALE OF WEANLING MUST BE ATTACHED**
